Animal Cruelty and Domestic Violence (l)What is Animal Cruelty? According to New York State Agriculture and Markets Law, animals are defined as "every living creature other than a human being [§ 350 (1)], whereby cruelty toward such beings "includes every act, omission, or neglect, whereby unjustifiable physical" [§350 (2)].
