It should have clearly identifiable objectives and pertain to a single or clearly identifiable group of activities, systems, programmes or bodies know as the "audited entity".

The European Court of Auditors (ECA) examines all revenue and expenditure by the EU or by bodies, offices or agencies set up by the EU. It assesses whether the EU's finances have been managed soundly, and whether all revenue received and expenditure disbursed has been carried out in compliance with the applicable regulations.
